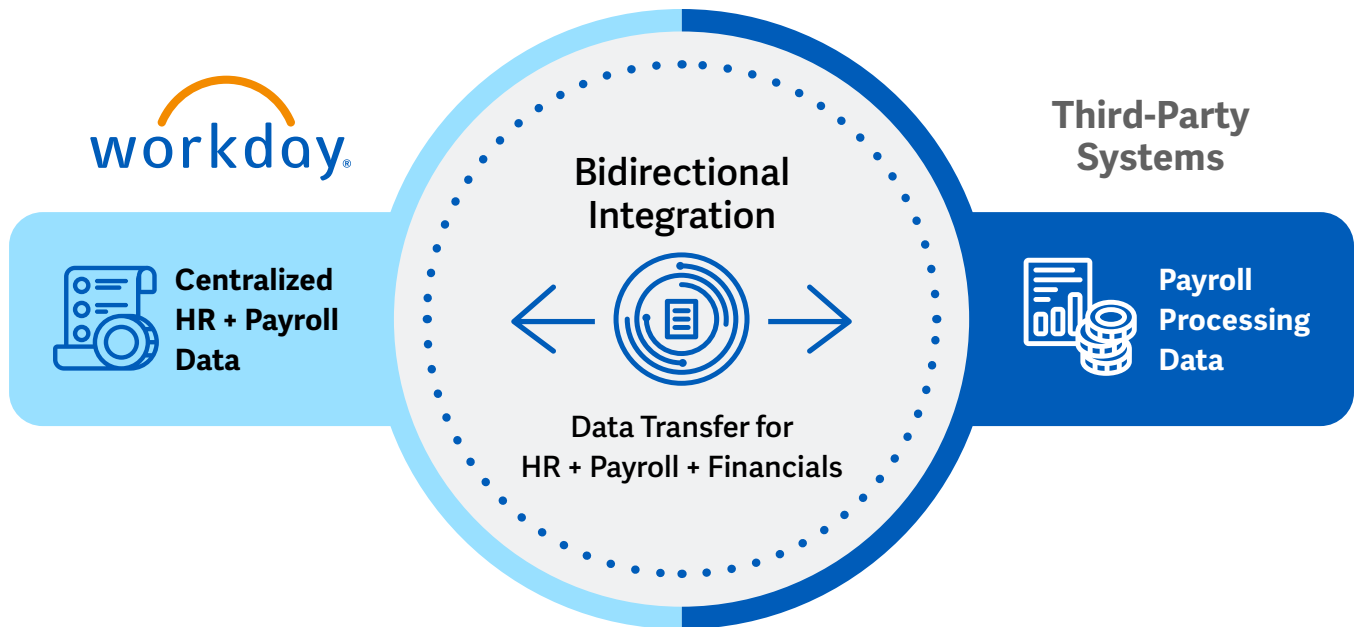
Third-party payroll connectors.

Workday offers connectors to provide a way for organizations to integrate bidirectionally to any third-party payroll system for a seamless global payroll experience. There are different payroll connectors, including the Payroll Interface (PI) connector and Payroll Effective Change Interface (PECI), which both enable extraction of the data changes in Workday and send data changes required for payroll processing to the provider systems. The data changes can be the direct results of Workday HCM worker events or other indirect data changes.

Key Benefits

- Connect to any number of third-party payroll applications, including global payroll providers.
- Enable seamless access to external payslips, tax documents, and other payroll-related documents via employee self-service.
- Enable global payroll labor cost reporting and analysis in a single currency using imported external payroll results.
- Configure Workday HCM integration fields to maximize alignment and ease of data transfer to providers.
- Leverage integration templates to create new integrations to send data changes to providers.
- Capture data changes within a time period and include them in the integration outputs in different formats (XML, Excel).

Workday Cloud Connect for Third-Party Payroll connectors enable you to:

- Capture all personal and job/position data within Workday HCM
- Assign employees to the appropriate pay groups directly
- Define pay period schedules, pay periods, earnings, and deductions, which can be assigned to compensation, benefits, and absence plans to automate data extractions to match your organization's required structure
- Organize pay groups to match the requirements of the payroll application
- Configure and populate custom payroll fields required by the payroll application
- Define transactions as one-time or one-off payroll events
- Transfer only the Workday HCM events that impact the payroll application for processing
- Restrict the amount of data transferred to the changes that occur within a time increment for a specific employee pay group
- Format and validate that the data conforms to the payroll application requirements; also create Excel spreadsheet to organize the data outputs
- Run an audit report to see exactly which data was captured, selected, and sent to payroll
- Automate and control data extractions and transfers to external payroll systems within the integration command center dashboard

Additionally, organizations can import data such as payslips and year-end tax statements from a third-party payroll provider back into Workday for employees to view using different form factors. Organizations can also import payroll result data from a third-party payroll provider back into Workday. The standard reports can combine external payroll result data with Workday payroll result data for a comprehensive view of labor costs across the global workforce and across both countries and providers. This new level of insight allows users to analyze data for more effective decision-making about how to:

- Improve cash forecasting
- Compare actual to budget
- Optimize pay ranges
- Manage allowances and overtime policies
- Better understand the true cost of the global workforce
